## MY ROLE RESPONSIBILITY

The People and Capability function is bringing to life a new identity and new ways of working and communicating that are consistent with our commitment to putting people at the heart of all we do, creating and enabling an environment in which everyone can thrive and changing the employee experience for all our people.

The Health and Safety Advisor role is responsible for supporting the Health and Safety Manager in the implementation of our key programmes of work to ensure successful outcomes through a transformational journey.







Specifically, the role is responsible for:

- Providing Health and Safety technical advice and guidance to support managers and staff across the CDHB and WCDHB including facilitating/supporting/reviewing Risk Assessments including oversighting of Risk Register development
- Supporting the development and implementation of health and safety initiatives and programmes in consultation with stakeholders (procedures, process, guidance and tools)
- Triaging incidents/near misses within Safety 1st technical expert and reporting concerns to Health and Safety Manager, monitoring quality of reporting, monitoring action completions and closing out
- Working with Patient Quality and Security to ensure all health and safety events are captured
- Promoting a proactive health and safety culture across the organisation
- Supporting the administration of the Worker Participation Framework
- Oversight of Health and Safety Committees ensures committee meetings are held and meet the requirements of the Terms of Reference and provide technical guidance and leadership where required
- Delivery of health and safety related training as directed by the Health and Safety
   Manager (where needs are identified and where internal training is appropriate)
- Serious Event Response and Investigations
- Supporting managers to conduct simple investigations and ensure appropriate corrective actions are identified, assigned and completed
- 1<sup>st</sup> party health and safety assurance activities to ensure compliance with legislative and audit standards, including Health and Safety Site Inspections
