<p>Role</p> <p>Purpose:</p>	<p>Te Tai o Poutini West Coast Mental Health System operated a recovery-oriented, community-based, connected, stepped care, locality Model of Care (the model). Specialist mental health, primary and community services, and Kaupapa Māori providers work collaboratively to ensure comprehensive cultural, clinical, psychosocial and acute crisis response is provided to the person and their family/ whānau.</p> <p>This role fulfils key functions in enacting the model to achieve clinical and recovery outcomes by ensuring support and other intervention accessed in primary and community services through collaborative care planning, shared and joint care between providers, and care stepped up or down as required. Care is coordinated to ensure timeliness, close gaps, remove duplication, and responsive to changing needs. Integration and ease of access for first time presentations or re-entry to services is enabled by joined-up referrals coordination through collaboration, engagement and joint assessments as indicated between sector providers inclusive of Health NZ- Te Whatu Ora Specialist Mental Health Services and all contacted mental health primary, community and Kaupapa Māori services (acknowledging other pathways are in place to access Kaupapa Māori Hauora Providers).</p>
<p>Position Objectives:</p>	<p>The Community Mental Health Nurse will utilise their knowledge and skills to provide safe and effective quality mental health care to service users and their family/whānau, enabling excellence in rural mental health outcomes in alignment with Te Whatu Ora, Te Tai o Poutini West Coast vision and values.</p> <p>Key functions of this role include:</p> <ol style="list-style-type: none"> Care: <ul style="list-style-type: none"> Undertakes all components of care coordination, including comprehensive assessment, risk assessment and management, recovery, and treatment planning. Uses an accepted clinical key worker or care coordination approach (previously referred to as a case management framework). Provides service user-centered care, that clearly involves significant others. Treatment that is provided is evidenced-based. Adheres to Service Provision Framework. Providing triage, assessment, crisis, and treatment services appropriate to client need <ul style="list-style-type: none"> Triages referrals, ensuring priority is allocated appropriately. Undertakes comprehensive mental health assessment, risk assessment and risk management planning in a culturally appropriate manner. Completes documentation in a timely fashion and ensures this meets minimum standards. Undertakes brief interventions over a time-limited follow-up period. Ensures family/whānau involvement is incorporated where possible.

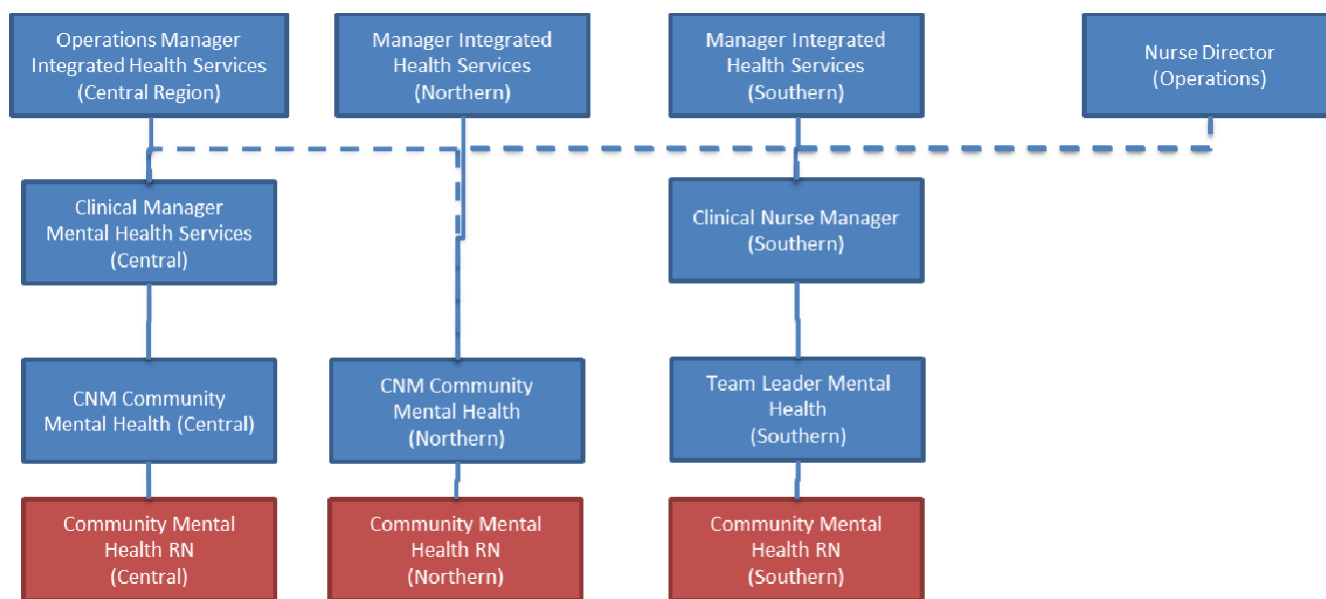

Using professional communication and negotiation skills to ensure appropriate and timely care from a range of services is coordinated in a cohesive way across the care continuum, embedding integration of services.

Communicating professionally with all who are involved in the care of a service user.

Contributes to creating a sustainable work environment that is fiscally responsible.

Documenting accurately and professionally and maintaining data security at all times.

Prevents, manages, and escalates matters of clinical risk appropriate.

- Uses evidence-based, approved assessment tools to inform assessment.
- Contributes to the successful transition to new ways of working informed by evidence-based practice, service need, and strategic priorities set by Te Whatu Ora, Te Tai o Poutini West Coast and government.
- Contributes to an organisational environment that values and prioritises the input of all service users and their families/whānau/community; ensuring that they are active and informed partners in the planning and delivery of their care.
- In partnership with the service user and their family/whānau, uses assessment skills to develop accurate, collaborative, holistic, documented care plans (including safety and transition plans) to support prevention and continuity of care.
- Plans and prioritizes care by collaboratively identifying health promotion and care management goals that are important to the service user and their whānau.
- Effectively and safely prioritizes and coordinates their own caseload.
- Within scope of practice, recommends diagnostic tests and therapies based on the service user's clinical presentation and care goals; explaining the rationale, preparation, nature, and anticipated effects of these tests and therapies. Documents these conversations as well as the service user response to these interventions.
- Within scope of practice, identifies evidence-based therapies and appropriate referrals to other services that meet the needs of the service user and their family/whānau. This is done in accordance with organizational policy and procedure.
- In partnership with the service user and their family/whānau, identifies opportunities for linking to relevant Māori Health services.
- Ensures the service user and their family/whānau are provided with culturally and cognitively appropriate information about: their rights, the range of treatment options available, and the effects and risks associated with these treatment options; seeking and documenting informed consent.
- In partnership with the service user and their family/whānau, identifies educational needs to improve health literacy and empower wellness.
- Provides education to service users and family/whānau effectively by assessing learning readiness, evaluating existing knowledge and determinants of health that may impact on learning and utilisation of new knowledge.
- Advocates on behalf of the service user, family/whānau, and/or colleagues as required.
- Identifies barriers related to accessing services, service user satisfaction and works with the interprofessional team to remove these.

- In partnership with the service user, their family/whānau, and the interprofessional team, regularly reviews and evaluates the care plan to ensure it is achieving the planned, prioritised care goals.
- Regularly attends multidisciplinary team meetings across the care continuum to promote continuity of care and seamless transition between services.
- Identifies service users within the service who could be cared for in the community with NGO support.
- Demonstrates risk assessment and management skills, and practises within a restraint minimisation and safe practice framework.
- Modifies practice, as appropriate, to take into account the impact of wider determinants of health, including changes to health strategy and models of care.
- Utilises resources in a cost-effective manner.
- Raises any resourcing issues with line manager in time for consideration during the preparation of relevant service plans and budgeting.
- Ensures all documented information is entered and adherent with Te Whatu Ora, Te Tai o Poutini West Coast policy.
- Ensures all collected information is stored and access-protected in accordance with the Health Information Privacy Code (1994).
- Documents in a professional, accurate, confidential, and timely manner (within 24 hours), and ensures service user, and family/whānau involvement in decision making is visible.
- Documents all information in the appropriate place (i.e. paper clinical file/electronically) to ensure effective communication and continuity of care. This includes reporting of contacts/data as required.
- Maintains and updates risk assessment information as per organisational requirements.
- Demonstrates an ability to collaboratively prevent, escalate, and manage adverse events/crises/emergencies, including unexpected service user responses and situations that may compromise the safety of the service user or others.
